# **ANTI-BULLYING PLAN - 2023**

# Dora Creek Public School

Bullying behaviour has three key features. It involves the intentional misuse of power in a relationship. It is ongoing and repeated, and it involves behaviours that can cause harm. The NSW Department of Education requires all NSW public schools to have an Anti-bullying Plan which details the strategies implemented to reduce student bullying behaviours.

### Resources

Schools are encouraged to visit the website to support whole-school prevention, early intervention and response approaches and strategies for student bullying behaviour.

#### Dora Creek Public School's commitment

Our school rejects all forms of bullying behaviours, including online (or cyber) bullying by maintaining a commitment to providing a safe, inclusive and respectful learning community that promotes student wellbeing. Executive staff are committed to establishing evidence-based approaches and strategies that promote a positive climate where bullying is less likely to occur.

# 1 School culture and inclusion

All members of the school community are active participants in building a welcoming school culture that values diversity and fosters positive relationships. A key component of a supportive school culture is building respectful relationships and an ethos that bullying is not accepted, in both online and offline environments. School staff will actively respond to student bullying behaviour.

Our school engages in the following practices to promote a positive school culture.

#### 1.1 Student assemblies

Student bullying and expectations about student behaviour will be discussed and information presented to promote a positive school culture where bullying is not accepted.

#### 1.2 Staff communication and professional learning

Staff will be supported with professional learning that provides evidence-based ways to encourage and teach positive social and emotional wellbeing and discourage, prevent, identify, and respond effectively to student bullying behaviour.

Term 1	Overview of Wellbeing systems and processes - whole school focus – PBL Expectations
Term 2	Revisit systems and processes - Anti-Bullying support plan and teacher role in this plan
Term 3	Familiarisation with on-line resources to support activities in the classroom - preparation for Action Day
Weekly	Segment in Communication meeting - Wellbeing/ LST - discussion, support offered, intervention as needed

#### 1.3 New and casual staff

New and casual staff will be informed about our school's approaches and strategies to prevent and respond to student bullying behaviour in the following ways.

Induction process for Casual teachers - When casual staff arrive at Dora Creek Public School, they are met by an Executive and are given an overview of school routines, systems and processes - wellbeing, traffic light system, use of SENTRAL (roll marking and recording of incidents).

Induction process for new staff - an executive member or Principal works through an induction with the staff member.

The Principal is responsible for the induction process for new executive staff.


## 2 Partnerships with families and community

# 3 Support for wellbeing and positive behaviours

Our school's practices support student wellbeing and positive behaviour approaches that align with our school community's needs.

Social and emotional skills related to personal safety, resilience, help-seeking and protective behaviours are explicitly taught across the curriculum in Personal Development, Health, and Physical Education (PDHPE).

Examples of other ways our school will embed student wellbeing and positive behaviour approaches and strategies in practices include the following.

•	Students are reminded of the Classroom and Playground Traffic Light system in the
	classroom and whole school assemblies

- K-6 students participate in lessons on National Day of Action against Bullying and Violence (August)
- Students participate in school funded incursions Yrs 4-6 Interrelate, K-3 Healthy Harold
- Weekly PBL lessons reinforcing expectations, positive behaviours + responding to and saying no to bullying
- Whole schoolbook system recognising positive behaviour -
- Student leadership team meet and define their role within the school supporting positive behaviour
